



<p style="font-size: small;">My name is Justin Clifton. I am a law enforcement investigator with the City of Gulf Shores Police Department. I am currently assigned to the criminal investigations division. I have approximately 15 years of experience in law enforcement. I have attended countless hours of training related to death investigations with the Alabama Department of Forensic Sciences, and the University of West Florida Forensics Department. I have written and served numerous search warrants and have been involved in the execution of these warrants to include the collection and preservation of evidence. In the evening hours of Sunday, May 16th, 2010, myself and members of my agency responded to the address enumerated in this search warrant application. At the scene the body of Angel Downs, who upon information and belief is the resident of this address, was found lying in the driveway with what is believed to be a gunshot wound to her head. A pistol was found near her body. The circumstances surrounding her death are suspicious and necessitate my application for a search warrant of the residence of Angel Downs to further investigate this matter in order to make a determination as to the presence of any criminal activity related to the death of Angel Downs.</p>
